



Terms and Conditions 2026

We are looking forward to welcoming our guests for summer 2026.

Please read this document carefully before your visit.

BEACH

SINGLE SUN LOUNGERS:

€30 hire fee (€10 rent + €20 amenities) PLUS €70 euro minimum spend per person. Shade is included in the price, 1 umbrella per 2 loungers.

•To confirm a reservation of 1 or more single sun loungers, we request the full amount (€30 hire fee + €70 euro minimum spend per person) in advance, in case of non-attendance or a cancellation outside the 4-day (96h) cancellation policy, we will not refund the deposit.

(Cancellation policy: full refund if notification of cancellation is prior to the 4 days before the reservation date.)

BIG BEDS:

€100 hire fee (€20 hire fee + €80 amenities) PLUS €500 minimum spend per big bed from Monday to Sunday. We require the full amount (€600) deposit per bed in advance (within 24h) to secure the booking, this amount will be deducted from the final bill. The big beds accommodate 4 guests.

•To confirm a reservation of 10 or more big beds, we request the full amount in advance, in case of non-attendance we will not refund the deposit. (in this case, cancellation policy is one month prior to the event date for full refund).

•Note that the deposit link expires 24h after receiving it via email

•Big Beds include one umbrella, a fruit bowl, and 1 can of water per guest, maximum of 4 cans per bed.

•Towels are available on request to rent or buy.

•We kindly ask our guests to arrive between 11:00 and 14:00 for Sun Loungers and between 11:00 and 15:00 for Big Bed reservations.

•Failing to do so will result in the LOSS of the reservation AND deposit.

•The Beach area service closes around 20:00.

Please note that a breakfast menu is served in the terrace area from 10:00 onwards and on the beach from 11:00 onwards. Minimum spend for the beach includes food & beverages from the beach menu. Restaurant bills and Lounge table bills are not included in the minimum spend of the beach beds.

RESTAURANT

To confirm a restaurant reservation of **1 to 5 guests**, we request a deposit of **€25 per person**.

To confirm a restaurant reservation of **6 to 12 guests**, we request a deposit of **€50 per person**.

For bookings of **13 or more guests**, we require a **100€ deposit per person**.

The deposit amount will be deducted from the final bill.

•Please note, if guests do not meet the required deposit amount, any remaining funds will not be refunded.

•If on the date of the reservation there are more guests than previously communicated and without prior notice of 24 hours, we do not guarantee seating at the same table or nearby. We will do our best to accommodate.

Cancellation policy: 4 days prior to the booking date

•Note that the deposit link expires 24h after receiving it via email

Unfortunately we cannot guarantee table specific location in advance.

Tables with 1 - 8 guests seating time is for 2 hours

Tables with 9 - 12 guests seating time is for 2.5 hours

Tables with 13 guests seating time is for 3 hours

•After the lunch/dinner, guests can join the Bar and enjoy the party.

•Please be advised that we will keep your table for 15 minutes after the time of reservation.

•Please notify us in advance if the number of guest changes in any way.

•Please note that Restaurant bills are not included in the minimum spend at the VIP or Beach areas.

•We kindly request confirmation of the number of guests under 18 included in the booking.

•On peak days, a short delay of approximately 10–15 minutes may occur; we appreciate your understanding and flexibility.

LOUNGE AREA VIP

•LOUNGE Tables for breakfast, available from 10:00am to 12:00pm

•LOUNGE Tables with Bottle Service: For tables with Premium Spirit or Champagne combinations, Terrace Menu, or Sushi Menu, a €250 deposit per table is required.

•LOUNGE Tables for Drinks (Before 17:00): Maximum seating time is limited to 2 hours. The last seating for drinks-only tables is at 15:00.

•LOUNGE Tables with Minimum Spend: A deposit equivalent to 100% of the minimum spend is required within 24 hours of booking confirmation.

•Minimum Spend After 17:00: From Thursday to Sunday, a minimum spend is required for all reservations after 17:00, which includes Premium Spirit or Champagne bottle service.

•**DEPOSIT CONDITIONS:** Deposit payment links expire 24 hours after being sent via email. Guests must arrive before 19:00 to avoid forfeiting their reservation and deposit.

We also reserve the right to modify table allocation or change a VIP table when necessary.

•**DRESS CODE:** Smart casual attire is required. Flip-flops are not permitted.

•**RESERVATION REQUESTS:** To book a VIP table, please complete your reservation at www.bluemarinibiza.com or send your request to our VIP Department at vip@bluemarinibiza.com. Our team will respond to your request as soon as possible.

GENERAL RESERVATION POLICIES

LUGGAGE STORAGE: We offer a safe and protected space for your belongings, suitcases or bags. Cost of €10 for each piece.

Please make sure to bring your reservation code from the confirmation email upon arrival.

CANCELLATION POLICY: Refund only when notified prior to the 96 hours before the reservation date.

IMPORTANT NOTE: A deposit is required in advance to confirm reservations. Without the corresponding deposit the reservation is not confirmed. The deposit will be deducted from the final bill at the end of the day; accounts will not be left suspended.

BEACH AND LOUNGE RESERVATIONS:

•Please note that for beach reservations and VIP terrace you will be asked to fill out the form upon arrival with the following information: Mr. / Mrs., ID / NIE / Passport No., Address, City, Mail, Telephone N., CCD, Address in Spain.

•We will keep your credit card until the invoice is finalized, however you can use another credit card or cash to complete the payment. * You must also provide a photo identification form. In the event that you leave the facilities without paying the invoice, Blue Marlin Ibiza will be authorized to collect the amount. By signing this document, you agree to these terms and conditions.

Finally, if you require an invoice, please let us know in advance so we can do it the same day, maximum time to do invoices will be one week after the date of the booking.

PRIVATE SECURITY-BODYGUARD

Access by private security is at the discretion of the company, in case guests are being accompanied by private security or bodyguards, these must check in with the client, present their credentials, show the equipment in use, (e.g. radio, personal defense equipment, etc.) in this way they will be shown the area in which they can position themselves.

EVENTS

We offer special deals and group menus for requests of 40 or more guests.

In order to accommodate guests, create a seating plan, allocate waiters according to language spoken, please confirm the following:

- Guests should have confirmed their travel itinerary to Ibiza
- Guests age range
- Nationality/Preferred language
- Male/female

We require a deposit in advance of 50% of the proposal to confirm the date, the second part one month prior to the event date by bank transfer.

We will kindly ask for details to create a PROFORMA and INVOICE, such as: Full Name/Company name, ID/Passport number, full address, city, cap.

Cancellation policy is one month prior to the booking date. Once the event is paid 100% it is non-refundable.
